MINECOFIN and EPRN Public Lecture on National Strategy for Transformation II 14th May 2025, 10am at University of Kigali (UoK) Kigali Campus

Background

The National Strategy for Transformation is a government developmental plan of the country which preceded after the Economic Development for Poverty Reduction Strategy. These strategies are ambitious road map to achieving Rwanda's overall developmental transformations. Along the way, some targets were met, and new strategy evolved to supplement past strategies. Over the period of NST I, under the economic transformation pillar, the country achieved steady economic growth, with Gross Domestic Product (GDP) expanding at an average of 7% and per capita income increasing from \$729 to \$1,040 in 2023. Under the social transformation pillar, life expectancy rose from 66.6 years to 69.9 years, reflecting advancements in healthcare and overall well-being. Under the transformational governance pillar, Rwanda has ensured continued stability, peace, and security, underpinned by a citizen-centered governance model, which is the foundation for realizing developmental gains. From NST I, now NST II, there are more to be achieve as the country draws to vision 2050 for sustainable economic growth, prosperity and high quality of life for all citizen, taking one step at a time.

The National Strategy for Transformation II is the country new developmental plan. With respect to the transformational pillars (economic, social, and transformational governance pillars) which are enshrined in the NST II, the strategy aims to deliver long-term success and positively impact on the lives of citizens by prioritizing sustainable development and climate resilience, development of domestic manufacturing industries to reduce the trade deficit, creating sustainable and decent jobs, improving the quality and relevance of education, enhancing nutrition and early childhood development to reduce stunting, improving the quality of service delivery while strengthening citizen engagement and participation.
